

happy and well, and do keep in touch—this time, on the web!



"The Administrative Office of Illinois Courts announced that 17th Judicial Circuit judges [Winnebago County] voted to select Phil Nicolosi as an associate judge. He fills one of two associate judgeships left open by retirement. Nicolosi, 54, has practiced law for 28 years in both civil and criminal courts and as both a prosecutor and defense attorney. He was Winnebago County State's Attorney from 2007 -2008 after being appointed to the job by the Winnebago County Board.

"'Nicolosi cares about the problems of the people who will appear before him in court,' said Dave Kurlinkus, deputy state's attorney and chief of staff. Kurlinkus worked with Nicolosi before opening his own practice and ultimately joining State's Attorney Joe Bruscato's team.
